Terms

Safe working environment:

During the ongoing Covid 19 pandemic, we continue to always maintain a safe and clean work environment, consistent with all health and safety laws. If anyone in the party is experiencing symptoms of Covid 19 or has recently tested positive for the virus, service will not be provided to them.

Deposit:

To secure a date a signed contract is required with 25% of total due at the time of signing. The deposit is non-refundable. Both the contract and deposit must be received before placing a hold on the requested day. Contract and deposit are due 60 days prior to the wedding date.

Cancellation:

In the event client cancels this agreement more than 30 days before the event date, client will only be responsible for paying the deposit. Cancellation must be sent via email nikkimaym85@gmail.com. Confirmation of cancellation notification by company must be obtained. If clients fail to let the company know of cancellation via email before the event date or cancels within 30 days of the event date, clients must pay the full balance due. If cancellation is received within a week of booking deposit will be refunded.

Payment:

All payment is due one week before wedding date. Cash, cheque or e-transfer are all accepted and can be made with Nicole or Elizabeth in person or over the phone.
